

Initial Setup




FIG. 1. Circulation System Setup

See FIG. 1. Connect high pressure moisture-resistant circulation lines (L) to circulation manifold (H). Route circulation lines back to return tube kit (M) at respective component A or B supply drum. Use hoses rated at maximum working pressure of the equipment.


Installation

To reduce the risk of explosion, do not cross-contaminate fluids when circulating. Be sure to circulate component A (isocyanate) to the component A drum and component B (resin) to the component B drum.

- 1. Remove block (2). Install circulation manifold (1) on gun fluid manifold (G). Open all valves in the fluid circuit.
- 2. Load fluid per instructions in proportioner manual.
- 3. Start proportioner. Set temperature targets. Circulate fluid at low pressure until temperature reaches targets.

 Close fluid valves A and B. Remove circulation manifold (1) from gun fluid manifold (G). Clean and apply grease to both check valves (5, 6). Attach block (2) to circulation manifold to prevent air from reacting with isocyanate.
